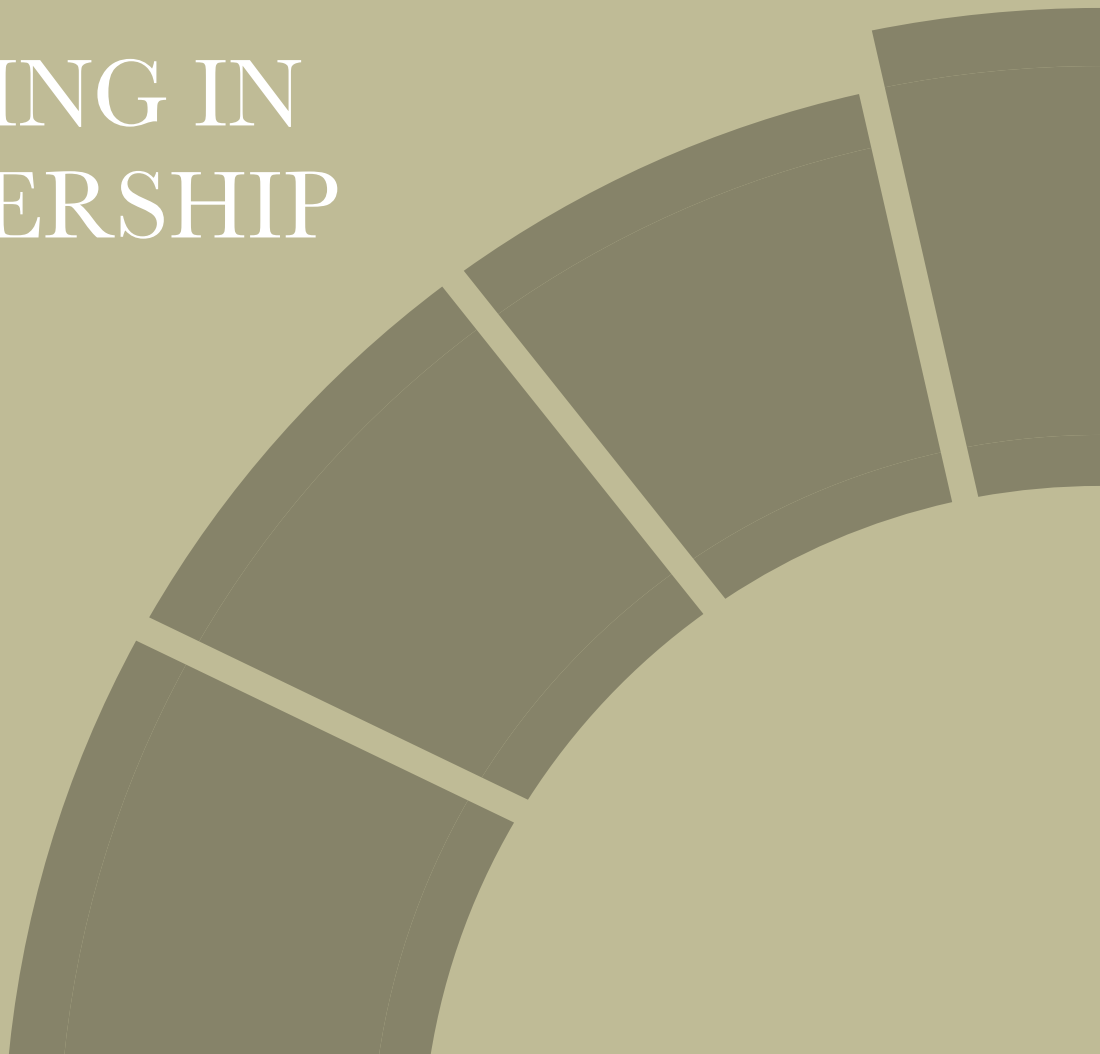
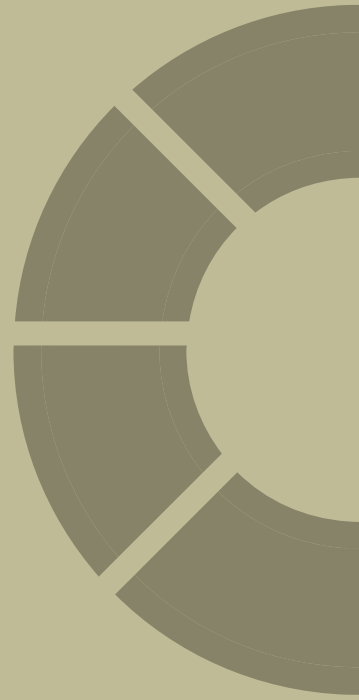

- Handle all investment decisions on a discretionary basis, so you don't need to worry about day-to-day management

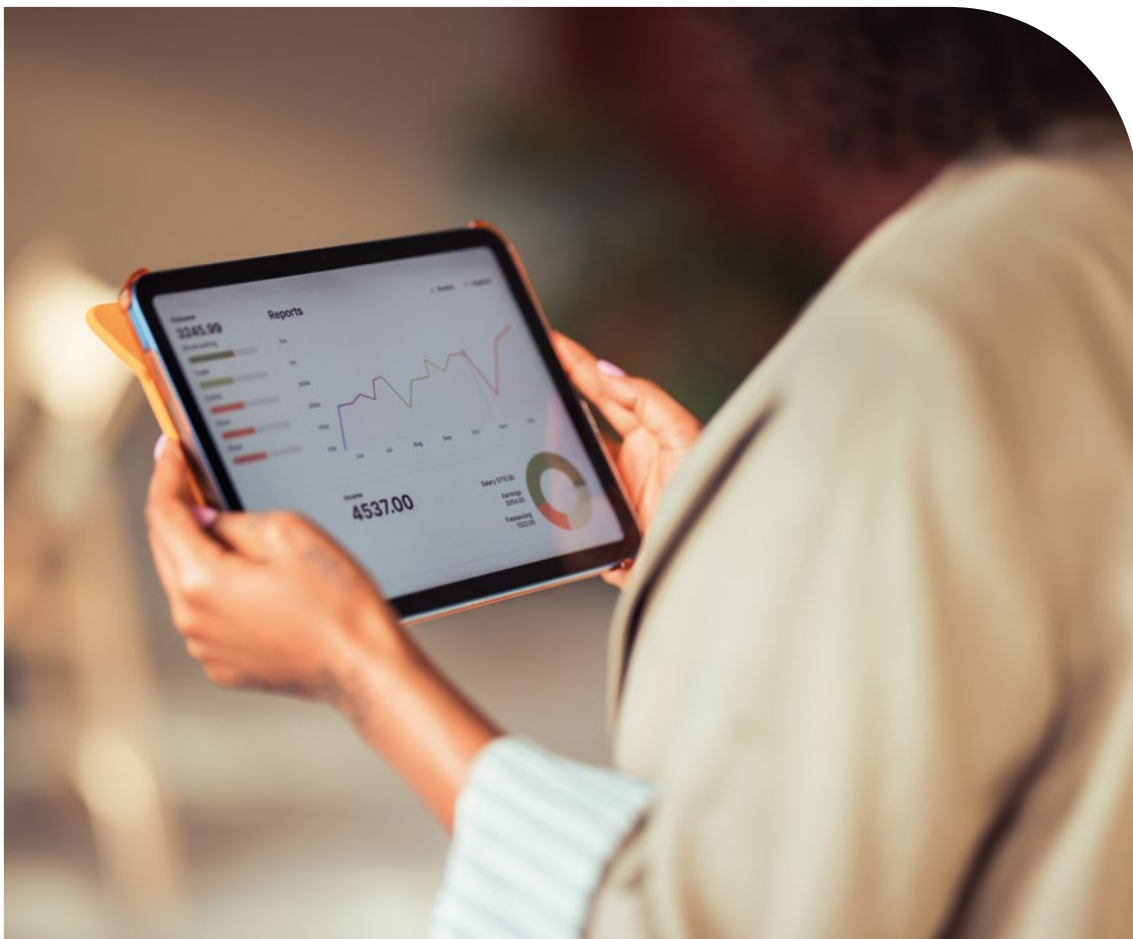
We invest across a broad range of asset types. These include equities, bonds, property and more - to ensure we have a good mix.
